Erie's Drinking Water is Safe

Consumers have always been interested in the quality of their drinking water. Interest piqued in 2015 when high levels of lead were found in the Flint, Michigan public water supply. Public outrage resulted in a nationwide effort to remove all sources of lead from public water systems.

The concern over a safe water supply hit the news again recently, with this emergency much closer to home. On February 2, 2023, 53 cars from a Norfolk Southern train derailed in East Palestine, OH. Five of the train cars were carrying hazardous materials (vinyl chloride). Several cars burned for two days which released hydrogen chloride and phosgene gas into the air. There was also evidence the chemical got into a nearby stream. Evacuations were ordered and bottled water was distributed to the affected residents.

The Erie Water Works (EWW) received several inquires from customers concerned if Erie's water supply may have been impacted by the accident.

The derailment occurred south of the Great Lakes Basin, meaning the affected stream runs naturally to the south and would not make its way to EWW's source water, Lake Erie. There is no indication that Lake Erie or its watershed

have been impacted. Furthermore, raw water samples taken on February 27, 2023 show no indication of contamination from the East Palestine train derailment. The

testing EWW regularly performs would identify any changes to our source water should they arise.

EWW treats and distributes about 25 million gallons of water through 775 miles of water main to more than 220,000 people



every day. The quality of the water is closely monitored by EWW Laboratory staff comprised of a Water Quality Manager, three Chemists, a Field Sampling Technician, and a Flushing Technician. This quality control takes place throughout the water treatment process, as well as throughout the piping network of the EWW water distribution system. EWW staff works hard to ensure its customers receive the highest quality water possible through continuous monitoring of the water from our treatment facilities to your tap.

If you encounter a work zone that can't be avoided please SLOW DOWN and pay close attention to signs and flaggers.

Property restoration work will also be underway soon. Most water main repairs made by EWW can disturb sidewalks, driveways, yards, and/or streets. When this happens our goal is to restore the property as quickly as possible. Unfortunately, with Erie weather, restoration work stops for the winter. Restoration work is typically assigned in the order the original work was completed. EWW appreciates your patience in this matter. Also, if grass restoration is done in front of your property please make sure to water it regularly.



Attention Millcreek Customers!!!

Millcreek Township is streamlining the billing process for trash and recycling services. Starting in April 2023, charges for refuse collection will be listed as a line item on the quarterly Erie Water Works bill.

The consolidated bill does not affect the contracted amount paid, nor does it affect the contracted hauler. The billing change will make the process more efficient.

If relevant, please update any automatic payments to reflect this change.

The unlimited refuse collection service is listed as \$93.09 quarterly in the contract for 2023.
